- GROUNDS MUST BE RESTORED TO THEIR ORIGINAL CONDITION

ALCOHOL/DRUGS:

- NO ALCOHOLIC BEVERAGES OR DRUGS ARE PERMITTED ON THE PREMISES. THIS IS STRICTLY ENFORCED. IF EVIDENCE IS FOUND, PARTY WILL END IMMEDIATELY
- ALL BOROUGH ORDINANCES WILL BE ADHERED TO

OCCUPANCY:

- OCCUPANCY OVER 200 PEOPLE REQUIRES A RESTROOM FACILITIES. THIS IS STRICTLY ENFORCED FOR SAFETY
- ANY INJURIES ON BOROUGH PROPERTY MUST BE REPORTED TO YOUR INSURANCE CARRIER AS SOON AS POSSIBLE AND AN INCIDENT REPORT FILED WITH THE POLICE AT THE TIME OF OCCURANCE

SMOKING:

- NO OPEN FLAMES OR GRILLS PERMITTED
- NO SMOKING IN PARKS, SEE SIGNAGE

DECORATIONS:

- ALL DECORATIONS MUST BE REMOVED BEFORE THE EXPIRATION OF RENTAL PERIOD. STAPLES, NAILS OR OTHER PENETRATING DEVICES ARE PROHIBITED

COMPLIANCE OF RULES AND ORDINANCES:
